

ASSOCIATION OF NIGERIAN AUTHORS CELEBRATES MEMBERS HONOURED ON DEMOCRACY DAY






ANA MOURNS MOKWA FLOOD VICTIMS, CALLS FOR URGENT GOVERNMENT ACTION

Authors (ANA) is utterly dismayed by the devastating flooding that has ravaged Mokwa, Niger State, resulting in the tragic loss of over 88 lives. In a statement jointly signed by its President, Dr. Usman Oladipo Akanbi, and Secretary, Dr. Dame Joan Oji, ANA expressed heartfelt condolences to the bereaved families and the entire Mokwa community affected by the disaster.

ANA likened this tragedy to the recent severe flooding in Maiduguri metropolis, emphasizing the increasing vulnerability of Nigerian towns and cities to climate-induced disasters. As a body of writers and cultural custodians, ANA expressed

deep concern over the human and environmental toll these disasters are having across the country, especially on already fragile communities.

The Association called on federal, state, and local governments to urgently investigate the root causes of the Mokwa flooding, including possible infrastructure failures and climate change impacts. It also urged authorities to initiate long-term infrastructural upgrades in the affected areas to prevent future occurrences. ANA reaffirmed its commitment to supporting the victims and using its platform to promote awareness and advocacy for disaster preparedness and mitigation.

OBA OF LAGOS THROWS WEIGHT BEHIND LAGOS WRITERS' VILLAGE

he Association of Nigerian Authors took a giant step in establishing a writers' village in Nigeria's commercial capital, Lagos, when a delegation, led by the national president, Dr. Usman Akanbi, and the chairman of the Lagos chapter, Dr. Olatunbosun Taofeek, paid a courtesy visit to the Oba of Lagos, Rilwan Akiolu, at the Iga Idunganran Palace in Lagos Isl

He said he would like the Lagos chapter of the association to have a writers' village in the city, one of the most important cities in the country and Africa. "Writing is the bedrock of the arts in Lagos. It is a bit surprising that a big association like ANA doesn't have a writers' village in Lagos, where writing and culture would flourish. We are looking forward to having such a place in



and recently.

Dr. Akanbi told the Oba that ANA's mandate included but not limited to preserving and promoting Nigerian literary culture and creating a thriving and flourishing ecosystem where writers could flourish. He reminded the king that the association was founded by pioneer Nigerian writers, led by Chinua Achebe, and had continued to serve the interests of Nigerian writers till date.

Lagos. We believe, with your prayer and support, we can get a ground to build a writers' village in Lagos." He promised to partner with the Oba of Lagos to develop a website to document the Lagos royal family as a giveback.

No doubt, the Lagos chairman, Olatunbosun Taofeek, is living his dream. Born in Lagos, Taofeek told the Oba, when he was elected the chairman of the Lagos chapter, he came up with the idea for the Lagos Writers' Village. He explained that the essence of the visit was to acquaint him as the father of Lagosians of the necessity of having a writers' village in Lagos and seeing how he could use his power to help make it come to fruition."

Taofeek reminded the revered king:

So, if that could be replicated by us in Nigeria, and, precisely, those of us from Western Nigeria, by building the writers' village, it isn't only going to help those of us writing currently in Nigeria but other coming generations and they will see it as a legacy that will help

provide a writers' village where other writers from Oxford, Cambridge and different parts of Africa should come to Africa and patronise, which can only be aided by the palace and the traditional institution, which owns lands in



Lagos and politicians in Lagos. He described Lagos as a major tourist destination in Nigeria."

He added that the village would also be beneficial to coming generations of scribblers: "Our young writers, even in Lagos, are not getting the expected opportunities that come with having a writers' village. They are more exposed to other artworks. When it comes to writing, it is more difficult, because there is no designated place where they can visit or see other old writers coming to or where they can have conferences and workshops, which the writers' village is going to

do for these writers who are coming and want to take writing as their trade."

In his response, the Lagos Oba said the suggestion made by ANA would be considered. According to him, "This is the kind of thing the

> society and Lagos would look up to. I hope you are coming with a genuine mind in order to pursue this kind of dream, not at the end of the day. you will see people fighting over money. If not the case, this is the kind of dream that is welcome in Lagos. And without anybody giving anything to anybody, the spirit and the power that

makes Lagos prosperous and the foremost city in Nigeria will make this dream come to pass.

"I would advise you to look at the Epe axis in Lagos, because there is still space where this kind of village can be built. Any support I can render as a father, I will do," he said, stressing that it was a worthy project the Lagos State Government could look into in order to attract foreign writers and tourists. He called on Nigerians to support the Tinubu administration to achieve its goals.

ANA SIGNS MOU WITH WIKIPEDIA

he Association of Nigerian Authors has signed a Memorandum of Understanding (MOU) with the Wikipedia Nigeria Foundation (Wikimedia) to enhance the visibility of its

members and their activities through capacity-building training. A brainchild of the Lagos chapter of the association, Dr Olatunbosun said the partnership would increase the online presence and visibility for ANA members. It

Olaniyan, the manager of Wikimedia Nigeria Foundation, welcomed the idea and vowed to collaborate with writers. "Sincerely speaking, if there is a partnership that ought to have engaged right from when we started, it ought to have been with

billion viewers accessing it on a monthly basis. Having 4.4 billion viewers out of 7.5 billion people in the world, means we need to do our work strategically in a manner we can be at the forefront and not the rear. So this is one of the

beginnings of such." He revealed two key challenges faced by Wikipedia to include sourcing good writers and quality information on Wikipedia. "When you have corrupt people and not quality contributors being at the forefront of an idea, it is either it begins to have poor information and fake news. Now that we want to engage authors, who are born writers, that means we are bringing quality contributors to serve as the face of Wikipedia. First, we have to start with capacity development by putting them through how our platform works.

"The second aspect of it, which is also contained in the MOU, is 'writing'. There is nothing you can't read in Wikipedia, except what is not e n c y c l o p e d i c. Wikipedia is not a news tabloid. It is a platform that records the trend of facts. We have to develop different workshops. One of them could be to document all the books

written in Nigeria, at least have an overview of what the books look like. Authors are notable people. We want to document as many notable authors as possible. We are going to teach you what makes an author or an event notable. Last but not least is public advocacy."

He noted part of the Nigerian copyright laws was inimical to authors. The restriction to the Freedom of Panorama in Nigeria is one of them. If this amendment is real, all authors are in trouble. Restriction to the Freedom of Panorama is saying that, for any copyrighted item in public space, you must take permission from the owner, except you show you can't make money out of it. What this means is, if you take a photo in public space without informing the owner of the property and put it in a book, you have violated the law. How many of our writers are aware of this?

"We need to form an alliance and let the government come down on some of these things. There is also a provision in the copyright law that says, when copyrighted item published, you need 70 vears after the death of the owner of the work to use it in your book. This needs to be reduced so that you will have good items to use in your books."

Dr. Akanbi said he was delighted Lagos ANA was championing this noble cause for Nigerian writers, a chapter that was sitting on the fence when he took over as ANA president. He promised to invite the Wikimedia Nigeria Foundation to the ANA convention in Abuja later in the year to sensitise Nigerian writers on Wikipedia's plans for writers. The delegation to both places also had Chimnemezu Nwaeze (Secretary, ANA Lagos) and Dr Tolu Ajayi (former ANA Lagos Chairman) in attendance.

ASSOCIATION OF NIGERIAN AUTHORS CONDEMNS ATTACKS IN BENUE STATE

he Association of Nigerian Authors (ANA) has expressed deep outrage over the continuous attacks on innocent civilians in Benue State, reportedly carried out by suspected armed herdsmen. According to the association, these gruesome incidents have resulted in significant loss of lives, displacement of entire communities, and a growing atmosphere of fear and insecurity in the region.

In a strongly worded statement issued by the duo of ANA President and ANA Secretary, Dr. Usman Oladipo Akanbi and Dr. Dame Joan Oji, ANA condemned the recurring violence, describing it as inhumane and unacceptable. The association noted that the victims of these attacks are often among the most vulnerable members of society—women, children, and the elderly—whose only crime is residing in their ancestral homes. It



stressed that the escalating brutality underscores the urgent need for government intervention.

The association called on both the state and federal governments to take swift and effective measures to address the root causes of the

conflict and prevent further bloodshed. It also urged relevant authorities to prioritize the protection of lives and property, particularly in rural areas that have been left exposed to repeated attacks.

ANA further emphasized the importance of a long-term, sustainable solution to the crisis. The group encouraged dialogue, inclusive governance, and community-based peace-building efforts as critical steps toward ending the cycle of violence. It called for accountability and justice for victims as essential components of national healing.

The Association of Nigerian Authors reaffirmed its solidarity with the people of Benue State and other communities experiencing similar tragedies. It pledged to continue using its platform and voice to advocate for justice, peace, and the preservation of human dignity across Nigeria.

A PRESIDENTIAL GESTURE OF HONOUR FOR KEN SARO-WIWA (CON): ANA RESPONDS

he Association of Nigerian A u t h o r s (A N A) h a s a c k n o w l e d g e d w i t h appreciation the recent posthumous national honour conferred on Ken Saro-Wiwa, former President of the Association, and his compatriots, during the 2025 Democracy Day celebrations by President Bola Ahmed Tinubu. This presidential gesture marks a significant

recognition of the sacrifice a n d contributions of the Ogoni Nine to the struggle for j u s t i c e, environmental rights, and democracy in Nigeria.

It will be recalled that during its 43rd Annual

Convention in November 2024, ANA established the Ken Saro-Wiwa Writers' Residency in honour of the iconic writer, environmental activist, and the Association's fourth President. The initiative, warmly received by the Saro-Wiwa family and widely celebrated in the media, reaffirmed ANA's unwavering commitment to preserving the legacies of Nigeria's literary and human rights heroes.

In a joint statement signed by ANA President, Dr. Usman Oladipo Akanbi, and General Secretary, Dr. Dame Joan

Oji, the Association reiterated its call for the full exoneration of Ken Saro-Wiwa and the Ogoni Nine, as urged by Dr. Owens Wiwa during the inauguration of the residency. While the conferral of national honours and the promise of a presidential pardon are steps in the right direction, ANA emphasized that a pardon alone is insufficient and unjust—it implies guilt where history and global

consensus acknowledge innocence.

ANA strongly maintains that the Ogoni Nine were victims of a judicial traves typerpetrated by a kangaroo tribunal under a military dictatorship. Their execution, widely condemned internationally, was a gross miscarriage

of justice. Therefore, the Association insists that only a full exoneration and appropriate compensation to the families can truly serve the cause of justice in a democratic society.

The Association of Nigerian Authors calls on President Bola Ahmed Tinubu to walk the full path of justice and right the historical wrongs committed against the Ogoni Nine. Anything short of exoneration and compensation would amount to a continued denial of justice under the guise of reconciliation.



ANA MOURNS KANO TRAGEDY, CONDOLES WITH GOVERNMENT AND PEOPLE OF THE STATE

Clarification on Membership and Activities of the Association of Nigerian Authors (ANA)

Apparently, the crisis in ANA, precipitated six years ago during the Association's botched 2019 Enugu Convention and Elections, had led some ANA members, especially at the state chapter level, to adopt a somewhat lukewarm approach to the Association's programmes and activities. In a number of states, ANA witnessed the emergence of splinter chapters, with only one faction seeking due recognition by the National Leadership whilst the other operated in isolation.

Fortunately, the present ANA National Executive Council has now successfully unified 30 chapters in actuality, all of which are working diligently in close collaboration with the NEC. These recognised state chapters are becoming increasingly attractive by their regular engagement in vibrant literary pursuits and social media visibility.

Let me, therefore, reiterate for the records that it is not mandatory nor compulsory for every state of Nigeria to establish an ANA chapter; rather, the Association's approach is to encourage creative writers to form their own chapters without any obligation to do. The Association has come of age and occupies an enviable position within the literary world, owing to its longstanding promotion of a literary culture and the calibre of intellectuals behind its founding over four decades ago. This distinction has enabled the ANA brand to stand out and remain relevant, not only in Nigeria but across the African continent.

However, it is pertinent to point out that the Association is neither a government parastatal nor a regulatory agency; it is a loose assemblage of passion-driven creatives and thought leaders, and, therefore, a nonprofit voluntary forum for creative writers. As a result of this status, membership is not obligatory for all Nigerian writers now restricted to an academic discipline for that. Instead, the primary motivation for joining ANA should be a love of literature and a passion for creative writing, borne of a desire by an individual to connect and network with fellow writers.

Therefore, let it be known henceforth that individuals who wish to join ANA and benefit from its opportunities must be willing to belong and behave appropriately, by adhering to the stipulated terms and conditions for full membership. In other words, only duly registered and validated members at the state chapter level shall be recognised by the National Office, the fulfillment of which entitles such registered members to present themselves as bona fide members of the Association at annual Conventions and Congresses. Being a writer alone does not automatically confer ANA membership on anyone. Let us be guided accordingly.



ANA URGES TINUBU TO GRANT POSTHUMOUS PARDON TO MAMMAN VATSA

he President of the Association of Nigerian Authors (ANA), Dr. Usman Oladipo Akanbi, has passionately called on the Federal Government of Nigeria to grant a p o s t h u m o u s presidential pardon to the late Major-General

Speaking to a gathering of writers, scholars, and literary enthusiasts, the ANA President emphasized Mamman Vatsa's profound contribution to the development of Nigerian literature and the institutional legacy he left behind. He

as a tragic loss not only to Nigeria's literary community but to the nation's cultural and intellectual history. He noted that the pardon would serve as a symbolic restoration of Vatsa's dignity and reaffirm his place as one of Nigeria's literary

icons. "Mamman Vatsa was not just a soldier; he was a man of letters, a poet whose works still resonate today,"

drew parallels
between Vatsa's
case and those of
other national
figures who have

received state clemency, including General Yakubu Gowon, General Olusegun Obasanjo, and the late Chief Emeka Odumegwu Ojukwu. He noted that clemency in such high-profile cases is not without precedent and called on President Bola Ahmed Tinubu to lead the way in healing national wounds.



Mamman Jiya Vatsa, a celebrated poet and writer who was executed in 1986 following allegations of involvement in a coup plot. Dr. Akanbi made this appeal during the second quarter session of the ANA Mbari Series, held under the theme, "Mbari Through the Eyes of the Founding Fathers."

recalled how, as Minister of the Federal Capital Territory, Vatsa allocated the land at Maitama Extension, Abuja, which has since become the permanent site of ANA's national headquarters—now known as the Mamman Vatsa Writers' Village.

Dr. Akanbi described the execution of Mamman Vatsa in February 1986


Adding their voices to the appeal were respected literary figures such as Lindsay Barrett and former ANA President Denja Abdullahi. Both men echoed the need for a national reckoning with history, stating that pardoning Vatsa would be a moral and cultural gesture that recognizes his contributions to Nigeria's literary heritage.

Dr. Akanbi urged all well-meaning Nigerians, writers, human rights advocates, and cultural stakeholders to rally behind the call for a posthumous pardon. He stressed that the act of forgiveness would be a symbolic gesture of national unity and reconciliation, especially for the literary community, which continues to celebrate Vatsa through events and institutions bearing his name.

He also referenced the Mamman Vatsa Writers' Village as a testimony to the enduring legacy of the late writer. The facility

is recognized as the largest writers' village in Africa and among the most significant globally. Dr. Akanbi emphasized that this should serve as a reminder of the great loss incurred with Vatsa's untimely execution and a call to justice for his memory.

The ANA President



also highlighted that a delegation had once visited the then Head of State, General Ibrahim Babangida, to plead for clemency before Vatsa's execution, stressing the controversy that still surrounds the case decades later. He said a presidential pardon would offer closure to lingering

questions and pain.

In concluding, Dr. Akanbi reiterated ANA's commitment to preserving Nigeria's literary history and supporting voices that have shaped the nation's cultural narrative. He called on the Federal Government to correct a historical wrong by posthumously pardoning Mamman Jiya Vatsa and recognizing him as a national treasure whose words and actions left an indelible mark on the soul of the nation.

The Association of Nigerian Authors remains hopeful that the call for clemency will not go unheard and that Major-General Mamman Vatsa's name will be rightfully restored in Nigeria's literary and national history.
